This product is not subject to any fixed term.

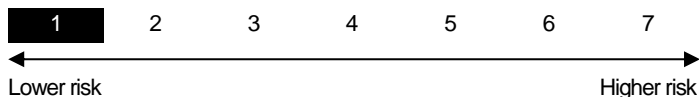
Objectives:

The Sub-Fund is an actively managed portfolio of mixture of cash deposits, commercial paper and bonds. Comprising bonds, ETFs, and CIS. The Fund may use forward foreign exchange contracts, futures, options for efficient portfolio management.

Intended Retail Investor:

This Fund may not be suitable for investors who plan to withdraw their money within 5 years.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to cash in early.

Risk indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 1 out of 7, which is the lowest risk class. This rates the potential losses from future performance at a very low level, and poor market conditions are very unlikely to impact the capacity of the fund to pay you.

The underlying funds may include illiquid assets such as alternative funds, real estate funds and/or non-quoted assets. Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs.
