### WHAT IS THIS PRODUCT?

This product is not subject to any fixed term.

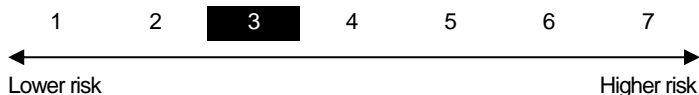
#### Objectives:

The Sub-Fund is an actively managed portfolio of broad and diversified range of global fixed-interest asset types. Comprising bonds, ETFs, and CIS. The Fund may use forward foreign exchange contracts, futures, options for efficient portfolio management.

#### Intended Retail Investor:

This Fund may not be suitable for investors who plan to withdraw their money within 5 years.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

#### Risk indicator

**We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the fund to pay you.**

### **Costs over Time**

The tables show the amounts that are taken from your investment to cover different types of costs.
