### WHAT IS THIS PRODUCT?

This product is not subject to any fixed term.

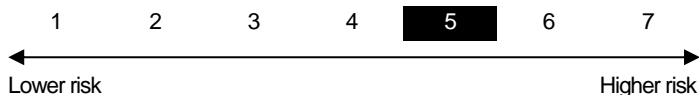
#### Objectives:

The Sub-Fund is an actively managed portfolio of broad and diversified range of Irish equities, which shall include companies domiciled in Ireland and/or companies having a substantial business interest in Ireland. Comprising equities listed on recognised markets, ETFs, and CIS.

#### Intended Retail Investor:

This Fund may not be suitable for investors who plan to withdraw their money within 5 years.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

#### Risk indicator

**We have classified this product as class 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the capacity of the fund to pay you.**

### **Costs over Time**

The tables show the amounts that are taken from your investment to cover different types of costs.
