### WHAT IS THIS PRODUCT?

#### Type:

This investment fund is a Retail Investor Alternative Investment Fund (RIAIF)

#### Term:

This product is not subject to any fixed term.

#### Objectives:

The Sub-Fund is an actively managed portfolio of broad and diversified range of long dated bonds. Comprising bonds, ETFs, and CIS. The Fund may use forward foreign exchange contracts, futures, options for efficient portfolio management.

#### Intended Retail Investor:

This Fund may not be suitable for investors who plan to withdraw their money within 5 years.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

#### Risk indicator

**We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the fund to pay you.**

### **Costs over Time**
