## WHAT IS THIS PRODUCT?

#### Type:

This product is not subject to any fixed term.


#### **Objectives:**

The Sub-Fund is an active portfolio, Comprising bonds and equities listed on recognised markets, ETFs, CIS and exposures to commodities. The Fund may use forward foreign exchange contracts, futures, options for efficient portfolio management. with 20 to 40 % of the Fund invested in assets other than cash and bonds.

#### **Intended Retail Investor:**

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

#### Risk indicator

We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the fund to pay you.
