### WHAT IS THIS PRODUCT?

#### Type:

This investment fund is a Retail Investor Alternative Investment Fund (RIAIF)

#### Term:

This product is not subject to any fixed term.

#### Objectives:

The Sub-Fund is an actively managed portfolio of broad and diversified range of asset. Comprising bonds and equities listed on recognised markets, ETFs, CIS and exposures to commodities. The Fund may use forward foreign exchange contracts, futures, options for efficient portfolio management.

#### Intended Retail Investor:

This Fund may not be suitable for investors who plan to withdraw their money within 5 years.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

#### Risk indicator

**We have classified this product as class 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the fund to pay you.**

## **WHAT ARE THE COSTS?**

### **Costs over Time**

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does.
