

We have classified this product as 1 out of 7, which is the lowest risk class. This rates the potential losses from future performance of the **underlying** at a very low level and the potential for us to be unable to pay you any amounts due as very unlikely.

The favourable, moderate, unfavourable and stress scenarios represent possible outcomes that have been calculated based on simulations using the reference asset's past performance over a period of up to 5 years. 5. How long should I hold it and can I take money out early?

Recommended holding period: 5 years
