



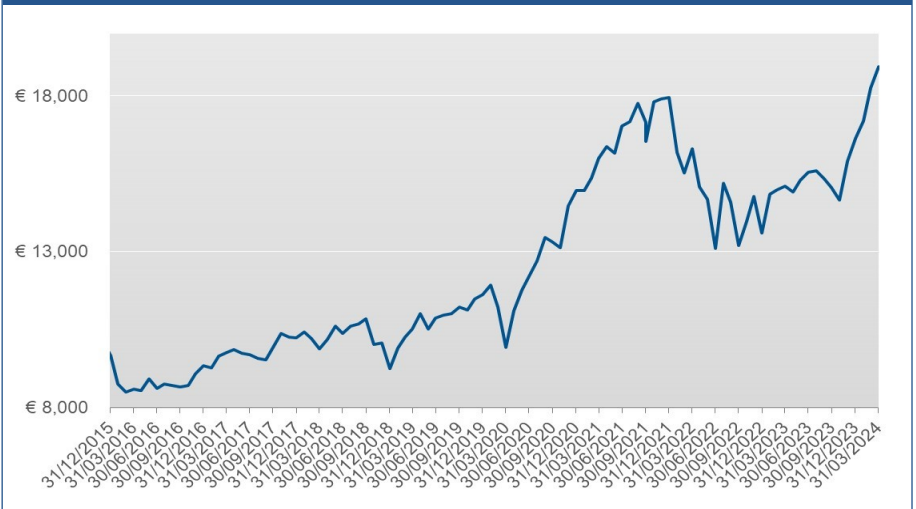

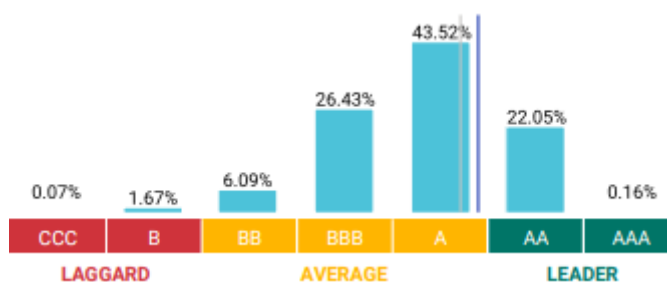

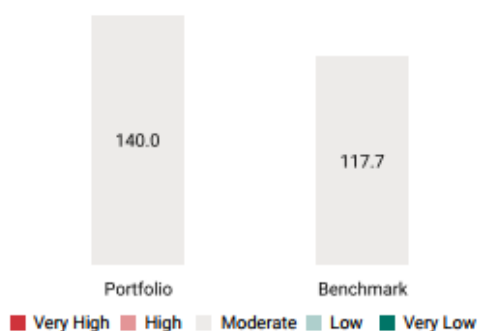
DISTRIBUTION OF MSCI ESG FUND RATINGS UNIVERSE



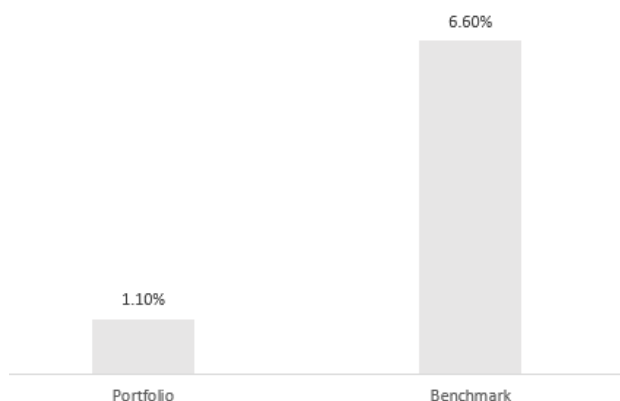

Carbon Risk is categorized as Very Low (0 to <15), Low (15 to <70), Moderate (70 to <250), High (250 to <525), and Very High (>=525)
