WHAT IS THIS PRODUCT?

Type	The product is in the form of a debt instrument, governed by English law
Term	The Maturity Date of the product is 24 April 2031 and it is recommended to hold the product until maturity.
Objectives	To provide a return linked to the level of the underlying. Amounts stated below are in respect of each Nominal Amount that you invest.

How the return is determined

- **Interest:**
 - **Interest Rate:** For each Interest Observation Date, the Reference Rate subject to a minimum equal to 2.80% per annum and a maximum equal to 3.75% per annum.
 - **Interest Amount on each Interest Payment Date:** You will receive the Nominal Amount multiplied by the Interest Rate and adjusted to reflect the proportion of days in the Accrual Period relative to one year, in accordance with the applicable day count fraction.
- **Redemption on the Maturity Date:** You will receive the Nominal Amount.

Early redemption and adjustments

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Summary Risk Indicator



The risk indicator assumes you keep the product until 24 April 2031. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because Crédit Agricole CIB is not able to pay you. We have classified this product as 1 out of 7, which is the lowest risk class. This classification takes into consideration two elements: 1) the market risk - that rates the potential losses from future performance at a very low level; and 2) the credit risk which estimates that poor market conditions are very unlikely to impact the capacity of Crédit Agricole CIB to pay you. **If the product is denominated in a currency other than the official currency of the Member State, be aware of currency risk.
