### WHAT IS THIS PRODUCT?

#### Type:

This investment fund is a Retail Investor Alternative Investment Fund (RIAIF)

This product is not subject to any fixed term.

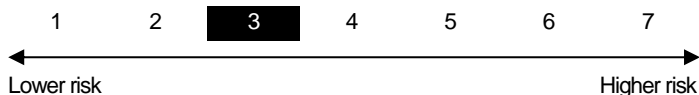
#### Objectives:

The Sub-Fund is an active portfolio, Comprising bonds and equities listed on recognised markets, ETFs, CIS and exposures to commodities. The Fund may use forward foreign exchange contracts, futures, options for efficient portfolio management. with 40 to 60 % of the Fund invested in assets other than cash and bonds.

#### Intended Retail Investor:

This Fund may not be suitable for investors who plan to withdraw their money within 5 years.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



**The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to cash in early.**

#### Risk indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

**We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the fund to pay you.**

## **WHAT ARE THE COSTS?**

### **Costs over Time**

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does.
