You are about to purchase a product that is not simple and may be difficult to understand

WHAT IS THIS PRODUCT?

Type	The product is in the form of a debt instrument, governed by English law
Term	The Maturity Date of the product is 25 September 2031 and it is recommended to hold the product until maturity, or until the manufacturer decides to early call according to the conditions specified below.
Objectives	Provide an Interest Rate on each Interest Payment Date. Amounts stated below are in respect of each Nominal Amount that you invest.

How the return is determined:

- **Interest:**
 - **Interest Rate:** 2.95% p.a.
 - **Interest Amount on each Interest Payment Date:** You will receive the Nominal Amount multiplied by the Interest Rate and adjusted to reflect the proportion of days in the Accrual Period relative to one year, in accordance with the applicable day count fraction.
- **Callability:** The Manufacturer has the right, but not the obligation, to redeem the product early on each of the Call Dates. In such event, you will receive the Nominal Amount.
- **Redemption on the Maturity Date:**
 - If the product is not early redeemed:
 - If Euribor 3 Month is in the Reference Rate Range: 100.25% multiplied by the Nominal Amount
 - Otherwise: 100% multiplied by the Nominal Amount.

- **Accrual Period:** for each Interest Payment Date, the period from and including the previous Interest Payment Date (or the Issue Date in case of the first period) to but excluding such Interest Payment Date
- **Interest Payment Dates:** 25 September 2025 and annually thereafter up to the Maturity Date (included)
- **Call Dates:** 25 September 2029 and annually thereafter up to the Maturity Date (excluded)

Early redemption and adjustments

The terms of the product provide that if certain defined events in addition to those described above occur (principally but not exclusively in relation to the product, any underlying, or the Manufacturer of the product (which may include the discontinuation of the Manufacturer's ability to carry out the necessary hedging transactions)), adjustments may be made to the terms of the product to account for the relevant event or the product may be early redeemed. The amount paid upon early redemption may be less than the amount originally invested.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Summary Risk Indicator



The risk indicator assumes you keep the product until 25 September 2031. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because Crédit Agricole CIB is not able to pay you. We have classified this product as 1 out of 7, which is the lowest risk class. This classification takes into consideration two elements: 1) the market risk - that rates the potential losses from future performance at a very low level; and 2) the credit risk which estimates that poor market conditions are very unlikely to impact the capacity of Crédit Agricole CIB to pay you. **If the product is denominated in a currency other than the official currency of the Member State, be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.** A risk that is materially relevant to the product but not included in the summary risk indicator is the risk that in the event the product redeems early due to an early call, you may be unable to reinvest your money at an attractive rate.
