You are about to purchase a product that is not simple and may be difficult to understand.

WHAT IS THIS PRODUCT?

TYPE

This product is a certificate, a transferable financial instrument.

TERM

This product has a fixed term and will redeem on the Redemption Date.

OBJECTIVES

The objective of this product is to provide you with a return based on the performance of an underlying index.

On the Redemption Date you will receive in respect of each certificate:

- 1. If the Final Strategy Price is greater than or equal to 125% of the Initial Strategy Price: a payment in cash of 125% of the Notional Amount.
 - 2. If the Final Strategy Price is less than 125% of the Initial Strategy Price:
- a. If the Final Strategy Price is greater than or equal to 100% of the Initial Strategy Price: a payment in cash equal to the Notional Amount increased by the Performance of the Strategy.
- b. If the Final Strategy Price is less than 100% of the Initial Strategy Price: a payment in cash equal to the Notional Amount.

Where:

- The Strategy is calculated recursively on a daily basis over the life of the certificate. The Strategy aims to replicate the performance of the Underlying fund with a mechanism of volatility control equal to 22% on a per annum basis with 0.5% of adjustment factor. The mechanism of volatility control is made by adjusting the weight allocated between the Underlying Fund and the Reference Rate in order to limit the volatility of the Strategy to 22% per annum (the maximum exposure of the Underlying Fund in the Strategy is equal to 200%)
- The Initial Strategy Price is the closing price of the Underlying on the Strike Date.
- The Final Strategy Price is the closing price of the Underlying on the Redemption Valuation Date.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

RISK INDICATOR



The risk indicator assumes you keep the product until maturity. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator (SRI) is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low risk level, and poor market conditions are very unlikely to impact our capacity to pay you.

You will receive payments in the product's currency, which may be different from your domestic currency. In this case, be aware of currency risk. The final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

You are entitled to receive back at least 100% of your capital (capital means Notional Amount). Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash-in before maturity.

If we are not able to pay you what is owed, you could lose your entire investment.

The duration of this product is uncertain as it may terminate at different times depending on how the market evolves. - In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MY MONEY OUT EARLY?

Recommended holding period: until 21 February 2030, which corresponds to the product's maturity.

However the duration of the product is not known in advance as it may be redeemed early.

The objective of the product is to provide you with the redemption profile described under "What is this product?" above. This only applies if the product is held until maturity.

Under normal market conditions, you may sell this product in the secondary market, at a price depending on the markets parameters prevailing at the time, which could put the invested amount at risk. Should you decide to resell, a fee of 0.50% will be deducted from the market price which could be increased under specific market condition.

The 0.50% commission has been taken into account in the table. In addition, the distributor may charge additional costs in the event of an exit before the maturity.
