## WHAT IS THIS PRODUCT?

This product is not subject to any fixed term.


#### **Objectives:**

The Sub-Fund will seek to achieve its investment objective by investing in a broad and diversified range of asset types with no specific focus on industry sector, geographic region or capitalisation level that can be considered Ethical Investments.

#### **Intended Retail Investor:**

This Fund may not be suitable for investors who plan to withdraw their money within 5 years.

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to cash in early.

#### Risk indicator

We have classified this product as class 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the capacity of the fund to pay you.

### **Costs over Time**

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does.
