WHAT IS THIS PRODUCT?

Type:

This investment fund is a Retail Investor Alternative Investment Fund (RIAIF)

Term:

This product is not subject to any fixed term.

Objectives:

The Sub-Fund is an actively managed portfolio of global equities. Comprising Transferable Securities, including bonds and equities listed on recognised markets, exchange traded funds ("ETFs"), collective investment schemes and exposures to commodities. The Fund may use FFCTs, futures, options for EPM.

Intended Retail Investor:

This Fund may not be suitable for investors who plan to withdraw their money within 5 years.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?
