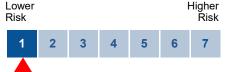
The Fund promotes a range of environmental and social characteristics, and is categorised as Article 8 in accordance with SFDR.

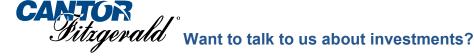
