WHAT IS THIS PRODUCT?

Type:

This investment fund is a Retail Investor Alternative Investment Fund (RIAIF)

Term:

This product is not subject to any fixed term.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?
