### WHAT IS THIS PRODUCT?

#### Type:

This product is not subject to any fixed term.

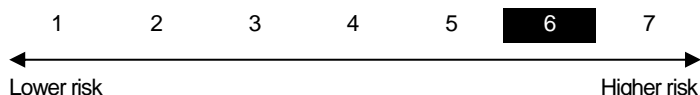
#### Objectives:

The Sub-Fund is an actively managed portfolio of broad and diversified range of asset types with a specific focus on the technology industry sector. Comprising equities listed on recognised markets, ETFs, and CIS. The Fund may use forward foreign exchange contracts, futures, options for efficient portfolio management.

#### Intended Retail Investor:

This Fund may not be suitable for investors who plan to withdraw their money within 5 years.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

#### Risk indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

**We have classified this product as class 6 out of 7, which the second highest risk class. This rates the potential losses from future performance at a high level, and poor market conditions are very likely to impact the capacity of the fund to pay you.**

### Costs over Time
