WHAT IS THIS PRODUCT?

Type:

This investment fund is a Retail Investor Alternative Investment Fund (RIAIF)

Term:

This product is not subject to any fixed term.

Objectives:

The Sub-Fund is an actively managed portfolio of broad and diversified range of global equities. Comprising equities listed on recognised markets, ETFs, and CIS. The Fund may use forward foreign exchange contracts, futures, options for efficient portfolio management.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

We have classified this product as class 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the Fund to pay you.
