WHAT IS THIS PRODUCT?

Type:

This investment fund is a Retail Investor Alternative Investment Fund (RIAIF)

Term:

This product is not subject to any fixed term.

Objectives:

The Sub-Fund is an actively managed portfolio of broad and diversified range of assets that can be considered Ethical Investments. Comprising bonds and equities listed on recognised markets, ETFs, CIS and exposures to commodities. The Fund may use forward foreign exchange contracts, futures, options for EPM.

Intended Retail Investor:

The investor must be a Qualifying Investor.

Have the ability to make an informed investment decision through sufficient knowledge and understanding of the product and its specific risks and rewards, with experience of investing in and/or holding a number of similar products providing a similar market exposure.

Have a long term investment horizon.

This Fund may not be suitable for investors who need access to their money. This Fund has an initial lock-period of two years during which redemptions are not possible.

Investors in this Fund should be willing to hold the investment for a time horizon in excess of 5 years.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to cash in early.

Risk indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the Fund to pay you.

The underlying funds may include illiquid assets such as alternative funds, real estate funds and/or non-quoted assets. These assets incur additional risks which are not considered in the indicator shown above when they do not represent a significant part of the underlying funds. These risks are that these assets could not be sold or not sold at the desired time and / or lead to significant losses.
