### WHAT IS THIS PRODUCT?

#### Type:

The Fund is a sub-fund of Cantor Fitzgerald Investment Funds PLC, incorporated with limited liability as an open-ended umbrella investment company with variable capital in the form of an undertaking for collective investment in transferable securities (UCITS). Your investment will take the form of shares in the Fund. The Fund's assets are held through its Depository, which is Northern Trust Fiduciary Services (Ireland) Limited.

#### Term:

This Fund is an open-ended UCITS and has an indefinite duration. The Fund may be terminated at any time in line with the constitutional documents of the Company.

#### Dealing Frequency:

Shares in the Fund can be bought and sold, either in whole or in part, every business day. An application must be submitted to the administrator, Northern Trust International Fund Administration Services (Ireland) Limited, by 4.00pm (Dublin Time) on the business day immediately prior to the business day of the purchase or sale. Alternatively, online dealing is available at a number of fund platforms. Further details on the conditions associated with the redemption of shares is included under the section "How long should I hold it and can I take money out early?"

#### Objectives:

The Fund aims to maximise the return on your investment through a combination of capital growth and income on the Fund's assets. The Fund applies prudent diversification criteria and will take into account both regional and sector diversification. The Fund's investment objective will be achieved by investing in equity securities (e.g. shares) listed or traded on recognised markets, but may from time to time also invest in cash deposits and fixed income securities (i.e. bonds) as protection in uncertain markets. The fixed income securities may be issued by governments, government agencies, companies and supranationals (e.g. the World bank).

#### Intended Retail Investor:

This Fund may not be suitable for investors who plan to withdraw their money within 5 years.

The price for buying and selling shares in the Fund is represented by the Net Asset Value (the "NAV") per share. The NAV per share of the Fund will be published daily and made available on the Investment Manager's website at <https://cantorfitzgerald.ie/asset-management/> and will be updated following each calculation of NAV.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

#### Risk indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

**We have classified this product as class 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the Fund to pay you.**

These assets incur additional risks which are not considered in the indicator shown above when they do not represent a significant part of the underlying funds.
